**WHEREAS**, the Canvass Board, as appointed by the Clerk and confirmed by the Council of the City of Ketchikan, has completed the canvass of the municipal election held on October 1, 2024, at the voting precincts of the City as established by the Lieutenant Governor, has certified the results and given its written report to the Council, and;
