Dear Mayor and City Council Members,

I wanted to provide a brief overview of what a Joint All-Hazard Mitigation Plan (HMP) update entails, as we move forward with this important effort for the City and Borough of Ketchikan.

An all-hazard mitigation plan is a FEMA-required document that identifies natural and human-made hazards that pose risks to our community and outlines strategies to reduce or eliminate their potential impacts. Updating this plan every five years is necessary to maintain eligibility for key federal mitigation funding programs, including FEMA's Hazard Mitigation Grant Program and the Building Resilient Infrastructure and Communities (BRIC) grants.

As part of this update, we are addressing the following identified hazards:

1. Flood
2. Earthquake
3. Tsunami
4. Severe Weather
5. Ground Failure – Landslide
6. Wildland Fire
7. Erosion
8. Dam Failure
9. Terrorism
10. Cyber Threat
11. Infectious Diseases
12. Hazardous Material Release

The “joint” aspect of this effort means the City of Ketchikan, the Ketchikan Gateway Borough, and the City of Saxman are working together to develop a single, regional plan. This collaborative approach ensures a unified strategy for risk reduction across jurisdictional boundaries and enables shared resources and coordinated public engagement.

The update process involves:

- Reviewing and revising hazard risk assessments based on current data
- Updating community profiles and capabilities
- Assessing progress on previously identified mitigation actions
