RE: **Authorizing Budget Transfers – 2020 Safer Streets and Sidewalk Program**

At its meeting of March 19, 2020, the City Council adopted a motion accepting the bid of SECON, Inc. in the amount of \$94,515 for Contract No. 20-06, Bawden Street Paving. The motion adopted by the City Council also established a five percent contingency in the amount of \$4,725, bringing the total project cost to \$99,240.

At its meeting of June 18, 2020, the City Council adopted a motion approving Change Order No. 1 (Final) to Contract No. 20-06, Bawden Street Paving, between the City and SECON, Inc. providing a net credit of \$20,346, bringing the total contract amount to \$74,169. At the time the change order was submitted to the City Council, Assistant Public Works Director Kara Jurczak noted that \$25,071 is available from the original appropriation and requested that amount be transferred to the 2020 Streets Division's Safer Streets and Sidewalks Program capital account to address additional sidewalk repairs in the downtown corridor.

As indicated in the attached memorandum, the Assistant Public Works Director has identified a project to replace a section of failing sidewalk on Mission Street, which would be best accomplished when it would not be disruptive to tourists and adjacent businesses. The estimated cost is \$37,000, which would require an additional transfer of \$11,929 from Appropriated Reserves of the Public Works Sales Tax Fund. I agree with Ms. Jurczak's recommendation.

Public Works Director Mark Hilson and the Assistant Public Works Director will be attending the City Council meeting of July 2, 2020, in order to address any questions and/or concerns that Councilmembers may have.

A motion has been prepared for City Council consideration.

## **RECOMMENDATION**

It is recommended the City Council adopt the motion authorizing the City Manager to transfer \$25,071 from the Streets Division's 2020 Bawden/Spruce Mill Way Pavement Repair capital account and \$11,929 from Appropriated Reserves of the Public Works Sales Tax Fund to the division's 2020 Safer Streets and Sidewalks Program capital account to replace a section of failing sidewalk on Mission Street.

**Recommended Motion:** I move the City Council authorize the City Manager to transfer \$25,071 from the Streets Division's 2020 Bawden/Spruce Mill Way Pavement Repair capital account and \$11,929 from Appropriated Reserves of the Public Works Sales Tax Fund to the division's 2020 Safer Streets and Sidewalks Program capital account to replace a section of failing sidewalk on Mission Street.

SUBJECT: **Contract No. 20-06, Bawden Street Pavement Repair – Budget Transfer**

In adopting the 2020 General Government annual budget, the City Council appropriated local funds in the amount of \$160,000 to the Public Work's Streets Division for Bawden/Spruce Mill Way Pavement Repair. The project was completed under budget with a funding surplus of \$25,071.00. Staff would like to utilize the remaining funds to complete a project on Mission Street, taking advantage of the reduced tourist traffic.

This section of sidewalk (see attached) was constructed on un-retained soil perched next to the adjoining building's open air crawl space. The un-retained fill has eroded over time leaving the sidewalk unsupported and slowly sinking. The adjoining building owner has made repairs to fill the void space left by the settling sidewalk but the sidewalk continues to sink away from the building. If not remedied, this situation will cause access issues for pedestrians trying to patronize these businesses and while urgent, this situation has the potential to become an emergency repair.

Reconstructing this section of sidewalk would be very disruptive to the adjacent businesses and pedestrian travel on Mission Street with a continuous excavation along the length of the building, four feet deep, parking restrictions, and construction related issues. With most downtown businesses suffering significant losses due to the lack of a cruise ship season, staff recommends completing this work now so we do not further impact these businesses next year. This work is estimated to cost \$37,000.00. Staff recommends funding \$25,071.00 from the Bawden/Spruce Mill Way Pavement Repair capital account and \$11,929.00 from the unappropriated reserves of the Public Works Sales Tax.

### **Recommendation:**

It is recommended that the City Council authorize budget transfers in the amounts of \$25,071.00 and \$11,929.00 from the Streets Divisions' Bawden/Spruce Mill Way Pavement Repair capital account and the unappropriated reserves of the Public Works Sales Tax, respectively, to the Streets Divisions' Safer Streets and Sidewalks capital account.

**RECOMMENDED MOTION:** I move the City Council authorize budget transfers in the amounts of \$25,071.00 and \$11,929.00 from the Streets Divisions' Bawden/Spruce Mill Way Pavement Repair capital account and the unappropriated reserves of the Public

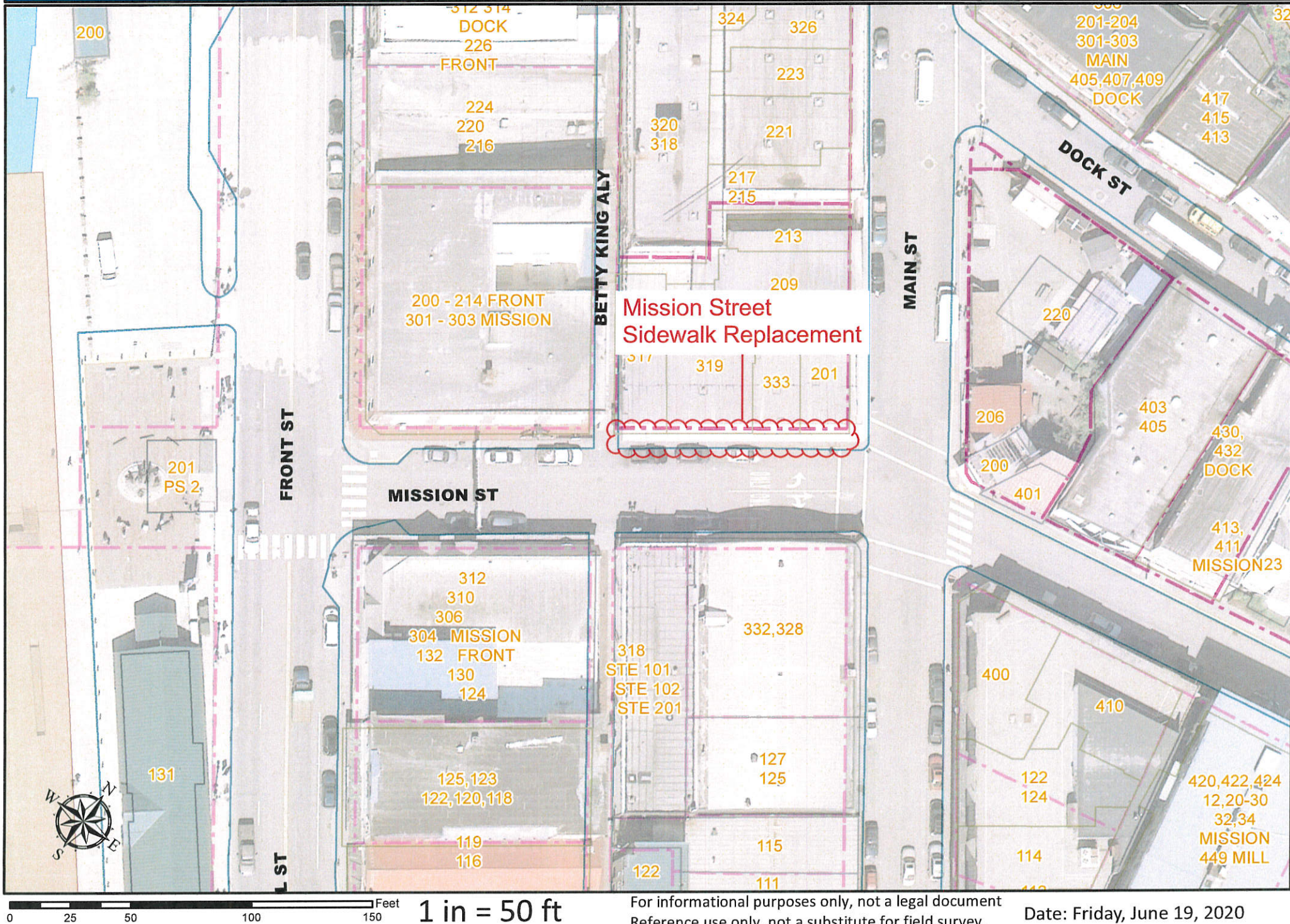
Works Sales Tax, respectively, to the Streets Divisions' Safer Streets and Sidewalks capital account.

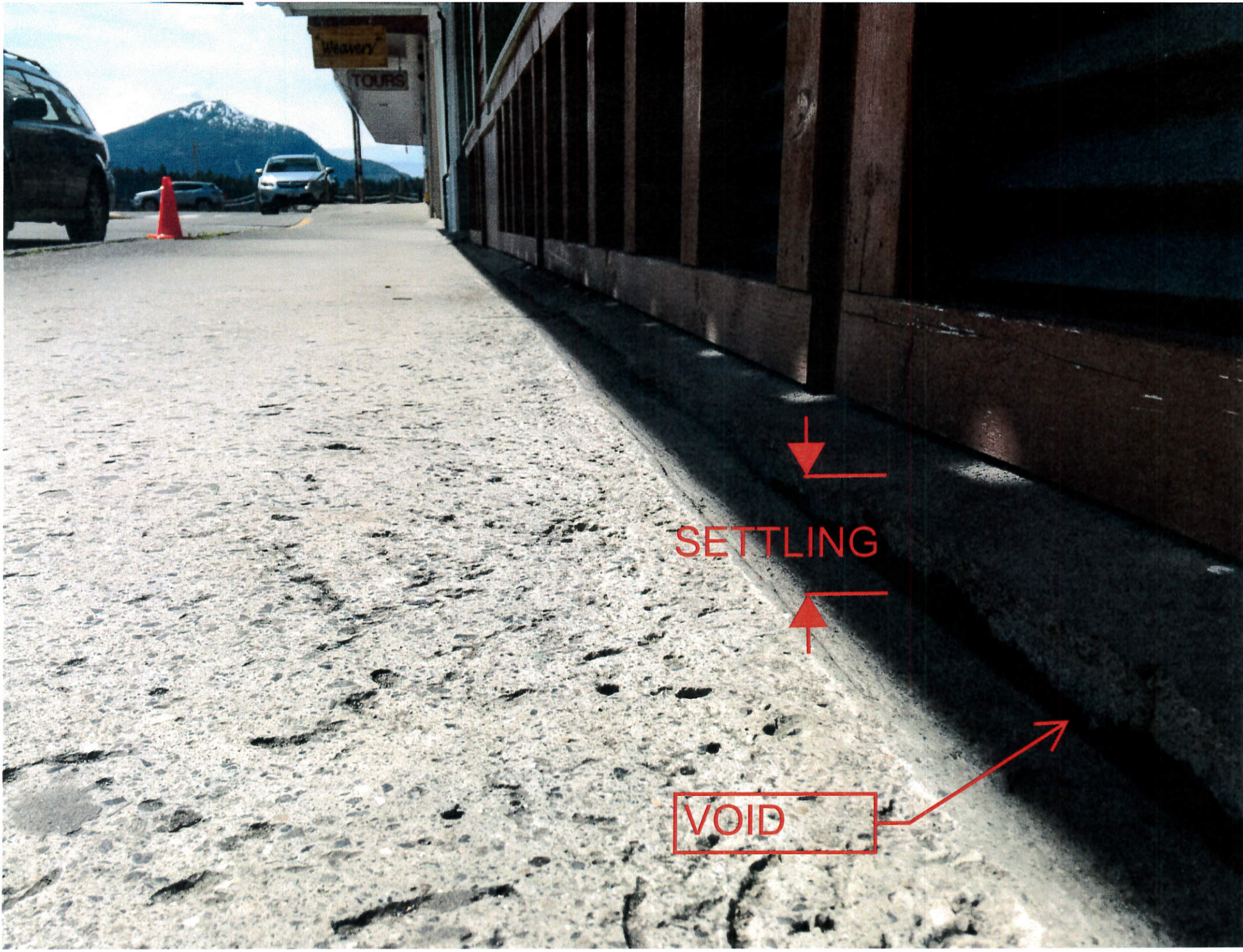

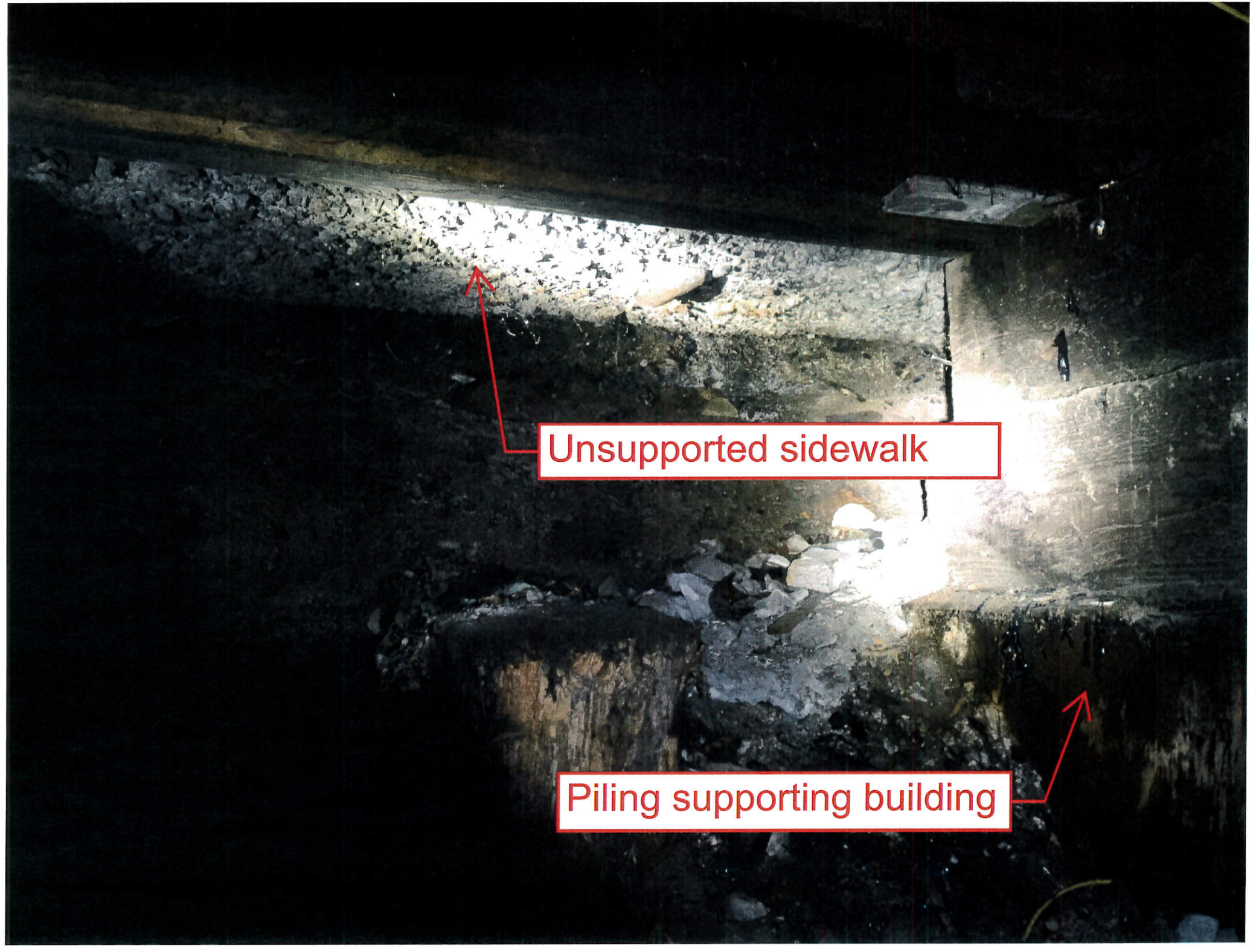
