## TRANSMITTAL MEMORANDUM

**RE:** Postponement of Electric Division Manager Retirement

By report dated October 3, 2019, my office advised the City Council of Electric Division Manager Andy Donato's intent to delay his retirement to March 31, 2021. Due to issues associated with the COVID-19 pandemic I requested, and Mr. Donato has agreed, to delay his retirement to the end of 2021. The Human Resources Division will initiate a formal recruitment no later than July 1, 2021. I wish to thank Mr. Donato for his willingness to stay on as Electric Division Manager for several more months.

Sam McQuerry, representing the First City Homeless Services, said they are in support of this project. He said this project is necessary and fits WISH's needs. He said the building will be a secure location for WISH clients. He indicated First City Homeless Services and WISH are partners, and they work together in the community to make it a better place. He thanked the Council for their support.

Dennis McCarty indicated he began with WISH back in 1979, and this was an incredible opportunity for WISH to get into this facility. He stated having a good facility can mean less emergency call-outs. He cited the services that are available in close proximity to the new facility. He thanked the Council for their support of this project.

Mayor Sivertsen asked for a show of hands for consensus of the Council to move forward with the Community Development Block Grant with the City of Ketchikan and Women in Safe Homes (WISH) application as their first priority, and at least four hands were shown.

Mayor Sivertsen declared the public hearing closed at 7:22 p.m.
