SUBJECT: Report on the Disbursement of CARES Act Funds – August 14, 2020

Attached to this memorandum is a report titled "Summary of CARES Act Disbursements to the Community" from Inception Through August 14, 2020. The intent of this report is to show the City Council the progress the City has made in disbursing CARES Act funds to the community.

At its meeting of July 2, 2020, the City Council passed and approved Resolution No. 20-2780, which appropriated \$7,119,347 from CARES Act funds to establish six programs designed to provide needed assistance to the residents and businesses of our community. Of this amount, \$5,919,347 is being funded from the City's first installment of its CARES Act award and \$1,200,000 is being funded from the Borough's first installment of tis CARES Act award. The programs approved are as follows:

As of August 14, 2020, the City had disbursed into the community \$885,913 of the \$7,119,347 available for distribution from CARES Act funds. Additional details about each program has been provide in the attached report. Assuming the City Council approves an agreement between the City and Borough at its meeting of August 20, 2020, the City expects to distribute \$2,480,000 to the Borough on August 21, 2020 for the Small Business Assistance Program.
