Interim City Manager Lacey Simpson and Members of the City Council:

2021 Fourth Quarter program highlights: Total in-person audience reached this quarter = 1,248. Online website visitors totaled 5,855, with over 62% being new to the website.

- Main Street Gallery:
 - October 1 29 "Space and Soul Together: A Retrospective" was a solo exhibit by Priscilla Thomas which celebrated space exploration and how it speaks to our shared humanity. Friday opening attendance was 74. Her artist presentation had 8 attend. KAAHC received 1,437 website visitors in October. Total in-person attendance for October was 215.
 - November 5 26, "Mycelium" featured Mary Ida Henrikson, with an opening attendance of 62. This exhibit presented an original, vibrant series of paintings celebrating mycelium: the underground thread-like body of fungus which creates a network of tendrils through the forest floor. The gallery in-person attendance for November was 239, while the website had 2,627 November visitors. Her artist presentation had 22 in total attendance.
 - December 3 10 "Youth in Art" Exhibit, an open call exhibit for all local youth with 17 artists had a Friday opening attendance during the Winter Art Walk of 130! The total attendance for the 1 week exhibit was 194. The KAAHC website received 1,791 visitors in December.
 - Total Main Street Gallery in-person visitors this quarter: 648.
- The 3rd Annual ARTober Art Walk on Friday, October 1, had 22 participating art businesses and galleries, with an amazing turnout throughout the downtown area. Many reported very high sales and gave very positive reports!
- The 22nd Annual Winter Art Walk on December 3 had 24 participating art businesses and galleries, and many participants reported high volume in attendance and sales. Event estimated attendance was over 500.
- The 32nd Annual Winter Arts Faire was all set to go with 54 vendors November 26-28 with a mitigation plan set in place: cutting booth numbers by almost 50% to allow at least 6' of space between booths, and requiring vendors and attendees to wear masks at all times. However, due to the continued high infection rate in the community and with the advice of health care experts to avoid large indoor gatherings, we cancelled the event out of an abundance of caution for the safety of our vendors and community. We did create an Online Winter Arts Market on our website which enabled 28 artists to have a high visibility for the holidays and provide a link to their sites for sales. The Arts Council featured each artist 3 times on their Facebook page Nov. 26 – Dec 25.
- Story SLAM!, the fall portion of our Stories at Latitude 56°, had 7 storytellers & 19 people attending on December 14.
- December 13 17 was the KAAHC annual gallery cleaning and painting week to prepare for a new year in 2022. The gallery and offices were closed December 20, 2021 to January 3, 2022 for the winter break.
