A RESOLUTION OF THE COUNCIL OF THE CITY OF KETCHIKAN, ALASKA, APPOINTING THE ELECTION OFFICIALS FOR THE REGULAR MUNICIPAL ELECTION TO BE HELD ON OCTOBER 4, 2022, APPROVING THE APPOINTMENT OF MEMBERS OF THE CANVASS BOARD AS AUTHORIZED BY THE CITY CLERK; AND ESTABLISHING AN EFFECTIVE DATE
