RE: Change Order No. 1 (FINAL) to Contract No. 21-18 – Ketchikan No. 4 Rotor and Stator Rewind, Delta Electric Motors

At its meeting of November 22, 2021, the City Council adopted a motion accepting the bid of Delta Electric Motors in the amount of \$363,500 for Contract No. 21-18, Ketchikan No. 4 Rotor, and Stator Rewind. The motion adopted by the City Council also established a contingency in the amount of \$36,350, bringing the total budgeted project cost to \$414,850 inclusive of a \$15,000 expenditure for factory acceptance testing.

The motion detailed below was prepared at the request of Acting Electric Division Manager Jeremy Bynum, who asked that it be placed before the City Council for consideration at its October 20, 2022, meeting. If adopted, the motion provides for approving Change Order No. 1 (final) to Contract No. 21-18 in the amount of \$40,314, bringing the total contract cost to \$403,814; this total amount is within the budgeted contingency funds. The rationale for the change order is detailed in Mr. Bynum's transmittal memorandum and requires no elaboration on the part of the General Manager's office; I concur with his recommendation.

The Acting Electric Division Manager will be attending the City Council meeting of October 20, 2022, in order to address any questions and/or concerns that Councilmembers may have.

A motion has been prepared for City Council consideration.

RECOMMENDATION

It is recommended the City Council adopt the motion approving Change Order No. 2 to Contract No. 21-18, Ketchikan No. 4 Rotor and Stator Rewind between the City d/b/a Ketchikan Public Utilities and Delta Electric Motors in the amount of \$40,314 bringing the total contract cost to \$403,814; authorizing funding in the amount of \$40,314 from the contract contingency; and directing the General Manager to execute the contract change order on behalf of the City Council.

Recommended Motion: I move that the City Council approve Change Order No. 2 to Contract No. 21-18, Ketchikan No. 4 Rotor and Stator Rewind between the City d.b.a. Ketchikan Public Utilities and Delta Electric Motors in the amount of \$40,314 bringing the total contract cost to \$403,814; authorize funding in the amount of \$40,314 from the contract contingency; and direct the General Manager to execute the contract change order on behalf of the City Council.

SUBJECT: Request Authorization for Change Order 1 to Contract No. 21-18 Ketchikan No. 4 Rotor & Stator Rewind

On November 22, 2021, City Council approved the award of Contract No. 21-18 Ketchikan No. 4 Rotor and Stator Rewind to Delta Electric Motors, An IPS Company, in the amount of \$363,500, including \$15,000 for KPU (Ketchikan Public Utilities) participation in Factory Acceptance Testing (FAT), and a \$36,350 contingency for a project total of \$414,850. KPU is requesting authorization of Change Order No. 1 in the amount of \$40,314, which would bring the actual project amount to \$403,814. KPU used \$3,000.63 for FAT, and the CIP account has a remaining balance of \$48,344.37.

The Change Order No. 1 includes a contract date extension and costs associated with unforeseen repairing of Unit No. 4 bearing journals, rebabbitting two (2) bearings, two (2) new oil rings, and shipping.

Recommendation: It is recommended that the City Council authorize Change Order No. 1 to Contract No. 21-18 Ketchikan No. 4 Rotor and Stator Rewind to Delta Electric Motors, An IPS Company, for the additional amount of \$40,314 and authorize the funding for Change Order No. 1 from the Ketchikan No. 4 Rotor and Stator Rewind CIP account.

Moved by Kistler, seconded by Mahtani the City Council accept the bid of Delta Electric Motors in the amount of \$363,500 for Contract No. 21-18, Ketchikan Generator No. 4 Rotor & Stator Rewind; approve the creation of a 2021 Electric Division Capital Account titled Ketchikan Generator No. 4 Rotor and Stator Rewind; establish a ten percent contingency in the amount of \$36,350 and Factory Acceptance Testing in the amount of \$15,000 bringing the total project cost to \$414,850; approve budget transfers in the amounts of \$252,000 from the Electric Division's 2021 Bailey Unit No. 1 Rehabilitation Capital Account and \$162,850 from the Electric Division's 2021 Beaver Falls Switchgear Replacement Capital Account to the newly created Ketchikan Generator No. 4 Rotor and Stator Rewind Capital Account; authorize funding in the amount of \$414,850 from the Ketchikan Generator No. 4 Rotor and Stator Rewind Capital Account; and authorize the Acting General Manager to execute the contract documents on behalf of the City Council.
