RE: **Ordinance No. 19-1900 – Amending Chapter 11.12, Telecommunications Service and Rates, of the Ketchikan Municipal Code; Providing for a Public Hearing; and Establishing an Effective Date**

The attached ordinance was prepared by Telecommunications Division Manager Ed Cushing, who requested that it be placed before the City Council for consideration at its meeting of September 5, 2019. If adopted, Ordinance No. 19-1900 formalizes rates for enhanced hosted data services and increased data transfer allowances, which were previously authorized by my office through interim tariffs. The details of and the rationale for the modifications are detailed in Mr. Cushing's transmittal memorandum and require no elaboration on the part of my office. I concur with the Telecommunications Division Manager's recommendation.

Mr. Cushing will be attending the City Council meeting of September 5, 2019, in order to address any questions and/or concerns that Councilmembers may have.

A motion has been prepared for City Council consideration.

This memorandum introduces Ordinance number 19-1900 amending Chapter 11.12 Telecommunications Service and Rates - for consideration by the City Council at the September 5, 2019 City Council meeting.

Ordinance number 19-1900 incorporates Interim Tariffs IT 19-0726 and IT 19-0411 into the Ketchikan Municipal Code (KMC).

Background

IT 19-0411 updates our Hosted Data and Managed Devices descriptions, services and rates. We have made significant upgrades to our Data Center, allowing us to offer better products and services. We have acquired new customers to the data center as a result. This IT moves most of the rates to ICB – individual contract basis - so that we may respond competitively to individual business customer's needs.

IT 19-0726 increases the data transfer usage amounts for most of our Internet plans. This IT was necessary to ensure our Internet plans remain competitive in the marketplace.

Approval of Ordinance No. 19-1900 will ensure that all rates, charges, modifications, changes and additions noted above are formally codified in the Ketchikan Municipal Code. Copies of Interim Tariff IT 19-0411 and IT 19-0726 are attached for City Council review.

ORDINANCE NO. 19-1900

AN ORDINANCE OF THE COUNCIL OF THE CITY OF KETCHIKAN, ALASKA; AMENDING CHAPTER 11.12 TELECOMMUNICATIONS SERVICE AND RATES OF THE KETCHIKAN MUNICIPAL CODE; PROVIDING FOR A PUBLIC HEARING; AND ESTABLISHING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF KETCHIKAN, ALASKA, AS FOLLOWS:

Section 1: Amendment: Section 11.12.070(m)(1) of the Ketchikan Municipal Code entitled “Hosted Data and Managed Device Services.” is amended as follows:

(m) Hosted Data and Managed Device Services. Hosted data and managed device services are offered as tarified rates as well as on an individual contract basis (ICB).

(1) Hosted data services include secure IT infrastructure with cabinet and rack space for storage, cross-connect service, blade server application, provision of Virtual Machine (VM) with options for storage and memory, ~~an ESXi virtual server, one-terabyte usable SAN storage, hosted camera service (requires additional purchase of SAN storage)~~ Managed Devices, setup and installation, power redundancy, environmental monitoring, and scheduled access.

(A) Cabinet/Rack space is a secured physical enclosure to house electronic equipment. Rack space is available in quarter, half and full rack sizes.

(B) Cross-connect service is the attachment of wires to connect circuits and allow them to speak to each other.

(C) A Blade Server is a physical, centrally managed computer which is housed on a smaller footprint and shares resources such as network cards and power in a central chassis. Several “blades” can be installed in a chassis thus reducing power consumption costs.

(D) A Virtual Machine is an operating system running in a shared environment on a server. The physical server manages the distribution of shared resources amongst the servers contained within it.

(2) Managed device services are offered based on the unique needs of business customers in the Ketchikan serving area. Wi-Fi includes three types of service: basic, advanced, and premium.

(A) KPU reserves the right to allocate excess bandwidth and provision the kpunet SSID out of the deployed access point.

(i) Basic Wi-Fi service delivers support for up to three SSIDs, to include a guest network, basic content filtering, and a basic “splash page” for the guest network.

(ii) Advanced Wi-Fi service provides support, with or without firewall, for up to eight SSIDs, to include a guest network, advanced content filtering, an advanced “splash page” for the guest network, radius integration, implementation of a “paid” SSID (customers can use their credit card for service), and a web portal for 24/7 visibility and network statistics.

(iii) Premium Wi-Fi service provides support for up to eight SSIDs, to include a guest network, advanced content filtering, an advanced “splash page” for the guest network, radius integration, implementation of a “paid” SSID (customers can use their credit card for service), and a web portal for 24/7 visibility and network statistics. Advanced security includes firewall protection, intrusion protection with antivirus and antiphishing filtering.

Section 3: Amendment: Section 11.12.090(b)(1) of the Ketchikan Municipal Code entitled “IP Network Service rates.” is amended as follows:






