Ms. Mackey has been a part of significant progress and changes for Ketchikan's visitor industry over the years, having been involved with the community's transition from resource-based industries to a booming tourism economy expected to welcome in excess of 1.5 million visitors this season. Patti has been innovative and inclusive in her approach to marketing Ketchikan as a premier visitor destination. The community owes Patti a great deal of gratitude, as our successes and growth were made possible due to Patti's efforts and commitment, and she will be missed as a colleague and partner of the City of Ketchikan.

I wish to take this opportunity to wish Ms. Mackey the best in her well-earned retirement and future endeavors.

RESOLUTION NO. 23-2879

A RESOLUTION OF THE COUNCIL OF THE CITY OF KETCHIKAN, ALASKA RECOGNIZING PATTI MACKEY FOR HER SERVICE TO THE COMMUNITY OF KETCHIKAN; AND ESTABLISHING AN EFFECTIVE DATE

- WHEREAS, Patti Mackey was born in the Little Flower Hospital on Bawden Street in Ketchikan; and
- **WHEREAS**, even though Patti grew up outside of Seattle, she never lost her connection to Southern Southeast Alaska, where her family had been for five generations; and
- **WHEREAS**, Patti returned to the First City more than 40-years ago where she met her future husband, Charles, and spent a summer with him on this trolling boat, and this month is their 40th Wedding Anniversary; and
- WHEREAS, Patti spent a decade working for KTKN Radio and made her first connection to the Ketchikan Visitors Bureau through its promotion of the Great Alaska Sportsfishing Championship; and
- **WHEREAS**, Patti then worked for longtime local politician Carroll Fader and the Tongass Historical Museum; and
- WHEREAS, Patti was hired by the Ketchikan Visitors Bureau in 1995 at a time when the community welcomed about 500,000 visitors each summer and the tourism industry was a smaller part of the local economy than the timber and fishing industries; and
- WHEREAS, Patti became the CEO of the KVB, and by extension the facing of the growing industry, that 38 years later will welcome up to 1.5 million visitors in 2023, and the industry is the largest economic engine in the community; and
- **WHEREAS**, Patti helped steer the visitor industry and the community at large through three major disruptions, the 9/11 2001 Terrorist Attacks, the severe industry-crippling recession of 2008, and the 2020-2022 COVID-19 Pandemic; and
- **WHEREAS**, in 2007, Patti was chosen as the board chair of the Alaska Travel Industry Association, just one of her many examples of regional and national outreach to keep Ketchikan at the forefront of the travel industry not just in Alaska, but worldwide; and
- **WHEREAS**, in the 2010s, Patti spearheaded the Ketchikan Story Project, which resulted in a series of Emmy-winning videos about various parts of the Ketchikan experience that not only was a boon to the visitor industry, but are a treasure to the community because they preserve Ketchikan history that otherwise might have been lost; and

WHEREAS, although Patti is retiring from her nearly 30-year stint at the Ketchikan Visitors Bureau in 2023, her decades of service to the visitor industry and the community is one of the most successful "runs" in Ketchikan history; and

WHEREAS, the City of Ketchikan and the Ketchikan City Council would like to congratulate Patti Mackey on her years of success, and wish her a most happy retirement, although we expect she will remain active going forward as a promoter of both the industry and of Ketchikan.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Ketchikan, Alaska as follows:
