# MEMORANDUM 7d TO: The Honorable Mayor & City Council FROM: Lacey G. Simpson, Assistant City Manager Initials: Initials: DATE: March 27, 2023 File #: MGR23-147 RE: Approving Resolution No. 23-2875, Adopting A Solid Waste Collection Fee Schedule; And Establishing An Effective Date

The motion detailed below was prepared at the request of Public Works Director Mark Hilson, who asked that it be placed before the City Council for consideration at its meeting of April 6, 2023. If adopted, Resolution No. 23-2875 sets forth a new solid waste collection fee schedule as outlined in Mr. Hilson's attached memorandum and appended to the proposed resolution. As indicated by Mr. Hilson, the operational costs of the Public Works – Solid Waste Division have rapidly increased in the past year due to a variety of factors. The division can no longer absorb these increased expenses while maintaining basic collection and disposal services, and adjustments must be made to the collection fees as proposed. The City's collection fees have not been increased since 2016.

The Public Works Director and Solid Waste Division Supervisor will be attending the meeting of April 6, 2023, in order to address any questions and/or concerns that Councilmembers may have.

**Recommended Motion:** I move the City Council approve Resolution No. 23-2875, adopting a Solid Waste Fee Schedule; and establishing an effective date.

### SUBJECT: Resolution 23-2875 - Increase Rates and Fees for Solid Waste Collection

In accordance with Ketchikan Municipal Code Section 7.16.072 City Council established fees for solid waste collection and disposal with the adoption of Resolution 20-2791. While this resolution increased disposal fees it did not increase collection fees (collection fees have not been increased since 2016). With the Federal Government's mandate regarding Commercial Driving License (CDL) training (not available locally), it has been difficult to staff collector positions, and as a result wages have had to increase in order to have staff to keep garbage moving. Also, wages in general have not been stagnant, with a 2% increase in the Collective Bargaining Agreement for 2022 and a 2.5% increase for 2023. Inflation has led to the cost of fuel and other items essential to our operations increasing substantially. We have been able to absorb these increases without raising rates due to Mr. Lenny Neeley's very successful streamlining of the Solid Waste Division. Unfortunately, it is no longer possible to cut costs and have the Solid Waste Collection Division absorb cost increases of this nature and remain solvent.

If adopted, attached Resolution No. 23-2875 provides for increasing a variety of nondisposal fees including increasing the Residential Collection Fee from \$10.69 to \$11.60 per month. New Non-Disposal Rates are included as Exhibit A to Resolution No. 23-2875. For reference, a comparison of current collection fees versus proposed fees is also attached to this memo.

In 2020, City Council recognized that significant automatic escalators prompting cost increases in transport and disposal would necessitate regular solid waste disposal fee increases. As a result, the City Council adopted Ordinance provisions to provide for annual adjustment of Solid Waste recycling and disposal fees in an amount equal to the increase in the city's

contractual costs for transport and disposal at an administrative level as approved by the City Manager. The 2023 transport and disposal fee increase is the subject of a separate memorandum and is planned to occur at the same time as the collection fee increases.

### **RECOMMENDATION**

It is recommended that the City Council approve Resolution No. 23-2875, adopting a Solid Waste Collection Fee Schedule and providing for an effective date.
