Authorizing Budget Transfer – City and Police Training Requests

The motion detailed below was prepared at the request of Finance Director Bob Newell, who asked that it be placed before the City Council for consideration at its meeting of March 5, 2020. If adopted, the motion provides for transferring \$8,000 from Appropriated Reserves of the General Fund to the Human Resources Division's 2020 Training and Education account (Account No. 600.03) and \$8,000 from Appropriated Reserves of the US Marshall Property Seizure Fund to the Police Department's 2020 Training and Education account (Account No. 600.03) to provide training in social media for the employees of the City, including the entire Police Department, and for law enforcement instruction to the Police Department. The rationale for the social media training is detailed in Lieutenant Andy Berntson's transmittal memorandum.

As City and Ketchikan Public Utilities staff increasingly utilizes social media for both work-related public communications and personal use, employees such as managers, supervisors, and staff would benefit from such training. Social media offers the unique opportunity to communicate with a wide cross section of the community. The City Manager's office believes employees should understand the impacts of social media use and how it may reflect upon their respective departments and divisions or the City and KPU as a whole.

Lieutenant Berntson will be attending the City Council meeting of March 5, 2020, in order to address any questions and/or concerns that Councilmembers may have.

A motion has been prepared for City Council consideration.

RECOMMENDATION

It is recommended the City Council adopt the motion authorizing the City Manager to transfer \$8,000 from Appropriated Reserves of the General Fund to the Human Resources Division's 2020 Training and Education account (Account No. 600.03) and \$8,000 from Appropriated Reserves of the US Marshall Property Seizure Fund to the Police Department's 2020 Training and Education account (Account No. 600.03) to provide training in social media for employees of the City and for law enforcement instruction to the Police Department.

Recommended Motion: I move the City Council authorize the City Manager to transfer \$8,000 from Appropriated Reserves of the General Fund to the Human Resources Division's 2020 Training and Education account (Account No. 600.03) and \$8,000 from Appropriated Reserves of the US Marshall Property Seizure Fund to the Police Department's 2020 Training and Education account (Account No. 600.03) to provide training in social media for employees of the City and for law enforcement instruction to the Police Department.

SUBJECT: Request for 2020 Budget Transfer- Police Department

Police Lieutenant Andy Berntson has requested funding for a social media training program for the Police Department. Since the program may benefit other city employees, it has been proposed to expand the training program to include them. The total cost of the training program is about \$16,000 including a small contingency of about \$626. The Police Department will absorb 50% of the cost of the training program. The Human Resources Division will cover the remaining 50%. It has been determined that the Police Department's share of the cost of the training program is eligible from reimbursement from the Forfeiture and Property Seizure Fund. The General Fund will fund the Human Resources Division's share.

Two budget transfers from appropriated reserves will be necessary to fund the proposed social medial training program. I am recommending a transfer of \$8,000 from the appropriated reserves of the Forfeitures and Property Seizure Fund and a transfer of \$8,000 from the appropriated reserves of the General Fund. Since the transfers will involve appropriated reserves, the City Council will need to approve the transfer.

For more information about the social media training program, please review the attached memorandum from Lieutenant Berntson.

Recommended Motion:

I move the City Council authorize the City Manager to transfer \$8,000 from the appropriated reserves of the General Fund to the Human Resources Division's 2020 Training and Education Account No. 600.03 and \$8,000 from the appropriated reserves of the Forfeitures and Property Seizure Fund to the Police Department's 2020 Training and Education Account No. 600.03 for the purpose of providing social media training for the employees of the Police Department and other employees of the City.

Subject: Social Media Training

The Ketchikan Police Department, in conjunction with the City of Ketchikan, is sponsoring employee training by well-known instructor Valerie Van Brocklin on 8/4/20 and 8/5/20. The training is titled "Public Employees' Rights, Responsibilities & Liabilities on the Internet – Roadkill on the Information Highway." Ms. Van Brocklin has put on this training for the City of Ketchikan in the past, and it is extremely valuable information for all government employees in reference to their rights and their use of the internet both during work hours and their personal time.

There will be two days of instruction and two travel days. One of the days of instruction would be City sponsored training and the other day would be sponsored by the Police Department and will include law enforcement specific instruction. Ms. Van Brocklin's cost is \$7000.00 per instruction day plus expenses. Those expenses would include:

- -Federal Per Diem Rate (4 days at \$95.00 per day for a total of \$380).
- -Three nights lodging (3 days at \$150.00 per night for a total of \$450.00).
- -Alaska Airlines travel round trip from Anchorage will be booked, paid and invoiced after travel by Ms. Van Brocklin (\$479.29).
- -Airport Parking in Anchorage will be paid and invoiced after travel (estimated 4 days at \$16 a day for a total of \$64.00) by Ms. Van Brocklin.

The total cost of the training would be estimated at \$15,373.29. The City of Ketchikan and the Police Department would each pay \$7,686.645. Costs subject to adjustment would be the plane ticket and parking, all others are fixed. Projected costs for the training should be no more than \$16,000.00, with the City of Ketchikan and the Police Department each paying \$8,000.00.



Public Employees' Rights, Responsibilities & Liabilities on the Internet

Roadkill on the Information Highway.

Police officers, fire fighters, EMS workers, dispatchers, court personnel, hospital staff, teachers, public works personnel, and other public servants are making headline news and suffering career damaging injuries or career ending fatalities because of their postings on the internet. They're also eroding public trust and hurting relations with their communities, other agencies, and funding sources – which makes their jobs tougher and, in some professions, more dangerous.

Telling these critical workers to "use common sense" or "don't post anything on the internet you wouldn't want to read in the newspaper" isn't working. There are complicated issues involved and while the technology leaps ahead, the law lags behind.

Consider this:

- Do public employees have any 1st Amendment freedom of expression on the internet?
- Do they have any 4th Amendment expectation of privacy to what they post on the internet?
 What if it is privacy protected?
- Do they have different responsibilities and liabilities for what they post because of the critical, sensitive nature of their work? If so, what are they?
- Do their rights, responsibilities and liabilities depend on whether they are ON or OFF duty or using a work or personal computer or cell phone?
- What actions can their agencies take against them for their internet postings?
- Can their agencies require them to divulge passwords in order to view their internet footprint for hiring due diligence, job promotions, or evaluations?
- How are opposing counsel in criminal and civil litigation discovering their internet footprint and using it against them and their agencies?
- How can they place themselves and their families in physical danger with their internet postings?
- How can they protect themselves from becoming roadkill on the information highway?

This training answers these questions with real scenarios, provides what agencies need to do to get ahead of the technology and legal curve, and, most importantly, gets attendees thinking before they "click."
