I received a BA in history from Southwest Minnesota State University in 1989 and a Ph.D. in history from Arizona State University in 1999 with fields in U.S., Russian/East European, and Public History.

In my home state of Minnesota I worked extensively with historical societies and museums as a consultant and author. I have a particular interest in local and regional history as well as the history of immigration. In addition, I have taught courses in historic preservation at American Military University. Here in Ketchikan I served as a member of the collections advisory committee for the City Museum department and worked as a summer guide for the Totem Heritage Center (both as tour guide and senior tour guide).
