RE: **Purchase of Palo Alto Network Security Appliances – Compunet Inc.**

The motion detailed below was prepared at the request of Information Technology Director Brock Hecla, who asked that it be placed before the City Council for consideration at its meeting of February 1, 2024. If adopted, the motion provides for approving the purchase of network security appliances and support services from Compunet Inc. in an amount not to exceed \$554,095 over five years (\$110,870 annually).

At the regular meeting of January 18, 2024, the City Council approved the purchase of Palo Alto network security appliances from MicroAge Inc. Since that approval, that vendor was unable to meet the exact demands and requirements of our City IT Department. Mr. Hecla has found the same appliances and support services through an alternate vendor who also has a National Cooperative Purchasing Alliance contract and can offer the same competitive price. This ensures we receive the services we need at a competitive price with the terms we demand.

In adopting the 2024 General Government Operating Budget, the City Council appropriated \$250,000 to the IT Department's capital account for the purchase of network security appliance replacements. As with the MicroAge Inc. product, the purchase is already exempt from competitive bidding or quotations pursuant to subparagraph 9 of Section 3.12.050(a)(9) of the Ketchikan Municipal Code (KMC) as we have secured highly favorable governmental pricing through NCPA Contract #01-107 but does require City Council approval pursuant to Section 3.12.035(c) as it is over \$50,000.

The rationale is detailed more fully in Mr. Hecla's transmittal memorandum. As this purchase is exempted from competitive bidding by the KMC with Council approval, the purchase is critical to maintaining the security of our network, the cost is included in the 2024 budget, City Council previously authorized the purchase on January 18 at this price and the contract has a non-appropriation clause protecting the City in future budget years, I concur with the recommendation.

A motion has been prepared for City Council consideration.

**Recommended Motion:** In accordance with Sections 3.12.050(a)(9) and 3.12.035(c) of the Ketchikan Municipal Code, I move the City Council approve the purchase of Palo Alto network security appliances with support services in the amount not to exceed \$554,095 via NCPA Contract#: 01-107 from Compunet Inc. over a period of five-years; authorizing funding from the Information Technology Department's 2024 Machinery & Equipment capital account #101-1160-190-725; and directing the City Manager to execute the purchase documents on behalf of the City Council.

**SUBJECT:** Procurement of Palo Alto network security appliances with five-years of support services in the amount of \$554,094.50 from Compunet Inc. Inc. via NCPA,01-107 contract over a five-year period with equal payments.

The purpose of this memorandum is to request that the City Manager seek City Council approval to purchase Palo Alto network security appliances with five-years of support services via contract#: NCPA,01-107 through Compunet Inc. If adopted, the approval motion authorizes the procurement of Palo Alto network security appliances and annual support and maintenance services from Compunet Inc. at a five-year cost of \$554,094.50 (\$110,869.90 annually)

On January 18<sup>th</sup> a motion was approved to purchase this equipment through MicroAge Inc. with similar terms and price. That vendor was unable or unwilling to meet the requirements negotiated by the City to complete a purchase post Council approval. We have since worked with another reseller of Palo Alto equipment to source the equipment we require with terms that are acceptable to parties.

**Background:**

The Information Technology (IT) Department employs network security appliances (firewalls), to meticulously scrutinize and regulate all Internet traffic. This approach ensures the robust protection of our network systems and data. An initiative to redesign and upgrade these systems is underway, aligning them with the latest industry benchmarks for cybersecurity. The primary objectives are to fortify departmental segmentation, bolster security filtering, and amplify visibility and control over both external and internal network traffic. Such enhancements are vital for safeguarding the City's essential functions against the ever-evolving landscape of cyber threats. While our security appliances have been diligently maintained with software updates through our support service contracts, the physical hardware, having been in operation for 10 years, necessitates replacement. As the demands of cybersecurity have evolved dramatically over the past decade, it's evident that older hardware may not offer the requisite bandwidth or features to counter contemporary and emerging cyber threats. This project endeavors to replace our current security infrastructure with industry-leading security appliances. These will be set up in a high-availability redundant configuration, providing network resilience. Such an upgrade will cement the City's network protection for the foreseeable future.

Recognizing the need for a predictable yearly budget and the value of long-term savings for the City, the Information Technology Department has worked with our vendors and develop a plan which we now present. We propose a five-year agreement for purchase of hardware along with support services. Payments would be evenly divided over five-year years and there is no interest accrued by the city to

enter into this agreement. This purchase not only eliminates the inflationary support cost increases we see year over year but significantly reduces the initial capital outlay required for the required network security upgrades. We will also realize a significant savings by agreeing at the time of purchase to five-years of support. I estimate based on historic yearly increases for support services seen within the industry and discussions with this specific vendor, a savings of \$281,530.40 over the five-year period is realistic.

The City Council appropriated \$250,000 to the Information Technology Department's Machinery & Equipment capital account, 101-1160-190-725.00 for the purpose of purchasing network security appliance replacements, with the intent of meeting the contemporary security and bandwidth requirements of the City. This request satisfies that directive through purchasing of the Palo Alto network security appliances with a support services contract for a term of five-years. First year funding would be using approved 2024 capital improvement project funds. This purchase is exempt from competitive bidding or quotations pursuant to subparagraph 9 of Section 3.12.050(a) of the Ketchikan Municipal Code (KMC), but the purchase does require City Council approval pursuant to Section 3.12.030) of the KMC as it is over \$50,000.

**Recommended Motion:**

I move the City Council approve the purchase of Palo Alto network security appliances with five-years of support services in the amount of \$554,094.50 via NCPA,01-107 contract through Compunet Inc. over a period of five-years and directing the City Manager to execute the purchase on its behalf.
